Requests for inspection of records of owners corporation

182 Requests for inspection of records of owners corporation

(1) Persons who may inspect An <u>owner</u>, <u>mortgagee</u> or <u>covenant chargee</u> of a lot in a <u>strata scheme</u>, or a person authorised by the <u>owner</u>, <u>mortgagee</u> or <u>covenant chargee</u>, may request the <u>owners corporation</u> to allow an inspection to be carried out under this section.

(2) Form of request The request must be made by written notice given to the <u>owners corporation</u> and be accompanied by the fee prescribed by the regulations.

(3) Items to be made available for inspection The <u>owners corporation</u> must make the following items available for inspection by the person who makes the request or the person's agent:(a) the <u>strata roll</u>,

(b) any other records or documents required to be kept under this Part,

(c) the plans, specifications, certificates, diagrams and other documents required to be delivered to the <u>owners</u> <u>corporation</u> before its first annual general meeting by the <u>original owner</u> or the <u>lessor</u> of a <u>leasehold strata</u> <u>scheme</u>,

(d) if in its custody or under its control, the certificate of title comprising the <u>common property</u> or, in the case of a <u>leasehold strata scheme</u>, the certificate of title for the lease of the <u>common property</u>,

(e) any applicable 10-year capital works fund plan,

(f) the last financial statements prepared,

(g) every current policy of insurance taken out by the <u>owners corporation</u> and the receipt for the premium last paid for each such policy,

(h) if a strata managing agent has been appointed, a copy of the instrument of appointment,

(i) if a strata renewal plan has been given to <u>owners</u> for their consideration under Part 10 of the <u>Strata</u> <u>Schemes Development Act 2015</u>, a copy of the plan,

(j) any other record or document in the custody or under the control of the owners corporation,

(k) if the duties of the <u>owners corporation</u> under this subsection have been delegated to a <u>strata managing</u> <u>agent</u>, any other records (including records of the <u>strata managing agent</u>) relating to the <u>strata scheme</u> that are prescribed by the regulations,

(I) if a <u>building manager agreement</u> is in force or has been entered into but has not yet commenced, a copy of the <u>building manager agreement</u>,

(m) particulars of any service agreement entered into by the owners corporation,

(n) particulars of any agreement entered into with a local council for a strata parking area,

(o) if the request is made within 5 years after the end of the <u>initial period</u>, particulars of any orders made under section 27 and copies of any related contracts or other documents.

Maximum penalty: 5 penalty units.

(4) Meeting inspections For the purpose of complying with requirements for the giving of notice of a meeting of the <u>owners corporation</u>, the <u>original owner</u> (whether or not having ceased to be an <u>owner</u>) or an agent authorised in writing by the <u>original owner</u> is entitled to inspect the <u>strata roll</u> without payment on making a written application.
